Thank you for the opportunity to review the application for water quality certification for the Shawmut Hydroelectric Project. NMFS expects to conduct a formal consultation under section 7 of the Endangered Species Act (ESA) on the licensing proposal contained in this application for water quality certification. We expect to proceed with ESA consultation upon FERC's formal request. As such, we do not believe that it would be appropriate to comment on the proposal until we have completed our analysis pursuant to our statutory responsibilities under the ESA. We did provide comments on FERC's July 1, 2021 Draft Environmental Assessment for the Shawmut Project, which I have attached for reference. We also expect to review and comment on FERC's anticipated draft Environmental Impact Statement (EIS) and final EIS associated with this project, expected August 2022 and February 2023, respectively.
