Somerset Economic Development Corporation is pleased to offer its support of Waste Management's proposed expansion to its Crossroads Landfill in Norridgewock,

Waste Management's Norridgewock facility is heavily relied upon by not just communities within our region but throughout the state. They offer both waste disposal and recycling services to municipalities and businesses at affordable prices allowing to effectively budget both public and private dollars. The Crossroads Landfill operates a state of the art, reliable and safe facility, so much so, they are running out of capacity. The proposed expansion would allow Waste Management to serve a critical state-wide need for years to come.
