Hi Jeff,

There has been more correspondence with the applicant within the past few days, and more interested persons' comments. I don't want to make the decision for you as to what is and is not relevant, so I'm afraid you'll have to come in to view them.

The hold does not mean we are not working on the review, it just extends the deadline. The hold will essentially remain in effect until we issue a draft of the Order. There will be no blanket notification to interested persons when the hold is removed, we will just issue the draft to those who have requested it. We will then allow at least five business days for additional comments to come in on the draft, make any appropriate changes, and issue the final Order.

We haven't found the Boyle file yet. The project manager transferred from the Augusta to Portland office during that review, and the file may be in a box somewhere in Portland. I will let you know when we find it.
