RE: Bucksport, Orland, Surry, Penobscot, and Blue Hill Inquiry Regarding Department Application #L-31353-36-B-N, Bucksport Mill LLC Petitions for Release from Dam Ownership

Dear Town Representatives:

The Department of Environmental Protection (Department) received three petitions for release from dam ownership (Petitions) from Bucksport Mill LLC (Petitioner) on October 18, 2024. The Petitions were found to be acceptable for processing on November 1, 2024. Bucksport Mill LLC is currently in the consultation process outlined in 38 M.R.S. § 902.

This letter is in response to your inquiry regarding the timeline of the Department's evaluation of the report on the consultation process that will be submitted under 38 M.R.S. § 902(4-A). Specifically, your towns asked whether § 902 allows the Department to defer issuing a decision on its evaluation of the report under § 902(5) if a town vote cannot occur on the issue until Election Day in November 2025.

The Department stated previously that it will place the Report filed under § 902(4-A) on our website for a 30-day public comment period after it is submitted and will consider any comments along with those already received during the consultation period.

The Department has no time constraint for evaluating the report under § 902(5), and it would be reasonable for the Department to delay a decision on the report if there is ongoing consultation with parties that may be willing to assume ownership of one or more of the dams in the petitions. Waiting on the results of a town election would be considered continued consultation to determine if a party would like to take ownership of a dam.
