I urge you to honor the will of Maine's voters. Revoke CMP's permit to construct the CMP Corridor.

We don't need the CMP Corridor; and we don't need CMP.

You see, we have things called solar panels and wind turbines and batteries. As soon as we mass-produce them for homeowners and small businesses, we can make them affordable through mass-production economies of scale. We Mainers will be able to generate our own electricity from our own rooftops or backyards. We won't need Central Maine Power. Electrical utilities like CMP will become extinct.

No more solar farms infesting our fields, no more giant windmills spoiling our mountaintops, no more transmission lines blighting our landscape, no more CMP Corridor cutting an obscene slash across our Appalachian Trail, no more Central Maine Power gouging us with absurdly inflated electricity bills.

Every Maine homeowner and Maine business owner will be able to generate his or her own electricity, buying it or selling it in community electricity co-ops -- democratic electricity! -- and our Maine landscape will become more attractive to tourists.

We already have the technology to replace Central Maine Power -- right now.

The CMP Corridor is already Dead On Arrival. Because the utility model for generating electricity is already, for all practical purposes, broken. And so will be CMP's power to torture our Maine landscape and to gouge us with bogus electricity bills.

CMP has claimed that Referendum Question 1 is unconstitutional. This is the height of arrogance and hypocrisy.

Our Maine Constitution, in Section 2, clearly states: "All power is inherent in the People."

Therefore, the will of Maine's voters, as expressed in Question 1, is *entirely* constitutional. It is CMP's continued construction of its **ugly** Corridor that is unlawful, unconstitutional, unnecessary, and -- obscene.
