And the said Central Maine Power Company does hereby covenant with the said Leroy B. Case, his heirs and assigns, that it will warrant and defend said premises to the said Leroy B. Case, his heirs and assigns forever, against the lawful claims and demands of all persons claiming by, through or under it but against none other.

In consideration of the sum of one dollar and the establishing of said boundary line by the parties hereto, as above set forth, the said Leroy B. Case does hereby remise, release, bargain, sell and convey and forever quitclaim unto the said Central Maine Power Company, its successors and assigns forever, all that part of land owned by him which is located on the westerly side of the above described dividing or boundary line which was acquired by him by said deed of January 17, 1945.

TO HAVE AND TO HOLD the above described premises, together with all the privileges and appurtunances thereunto belonging to the said Central Maine

Power Company, its successors and assigns forever: And the said Leroy B.

Case does hereby covenant with the said Central Maine Power Company, its successors and assigns, that he will warrant and defend said premises to the said Central Maine Power Company, its successors and assigns forever, against the lawful claims and demands of all persons claiming by, through or under him, but against none other.
