Know all men by these Presents,

That I, ELWIN S. NORRIS of Livermore Falls, Androscoggin County,
Maine,

in consideration of One Dollar and other valuable consideration

County, Maine

the receipt whereof I do hereby acknowledge, do hereby give, grant,
convey, sell and runny, unto the said

CENTRAL SECURITIES CORPORATION

Its Successors ~~Heirs~~ and Assigns forever,
A certain lot or parcel of land in the town of Livermore Falls,
Androscoggin County, Maine, bounded and described as follows:

A strip of land four hundred (400) feet in width, extending
from my northerly to my southerly line and bounded northerly by
land now or formerly of John F. Blanchard; easterly by a
line parallel with and sixty-two and one-half (62½) feet
easterly of a survey line now staked out across my lot the
Blanchard lot and the Dana R. Knowlton lot; southerly by land
now or formerly of Dana R. Knowlton; westerly by a line parallel
with and three hundred thirty-seven and one-half (337½) feet
westerly of the survey line above described. Containing about
twenty-seven (27) acres.

Excepting from the above, any right of the public to the
use of a highway across said lot.

My title to the above property is derived by deed from

Reserving to the grantor herein, an easement or right of
way across the above described parcel of land for lumbering
and agricultural purposes not to exceed twenty (20) feet in
width and to be located by the grantee in some location con-
venient for the said grantor and which will not however, inter-
fere with the use of the said above described parcel in connec-
tion with the transmission of electric energy.

Reserving also to the grantor herein, the wood and lumber
on said parcel, said wood and lumber to be removed by the
grantor on written request of the grantee. Or, if not removed
by the grantor in season to avoid interference with construction
or maintenance work, the grantee may cut and remove said wood
and lumber at its option. The grantor herein to dispose of
any slash caused by any of his operations on this lot in
accordance with the State Slash Law.
