the receipt whereof I do hereby acknowledge, do hereby give, grant, bargain, sell and convey, unto the said

CENTRAL SECURITIES CORPORATION

Its Successors ~~Heirs~~ and Assigns forever,

A certain lot or parcel of land in the town of Greene, Androscoggin County, Maine, bounded and described as follows:

A strip of land four hundred (400) feet in width extending from my northerly to my southerly line and bounded northerly by land now or formerly of Frank E. Merrill at the road; easterly by a line parallel with and sixty-two and one-half (62½) feet easterly of a survey line now staked out across my lot, the Merrill lot and the Moulton lot; southerly by land now or formerly of Almon B. Moulton (an irregular line); westerly by a line parallel with and three hundred thirty-seven and one-half (337½) feet westerly of the survey line above described. Containing about two and seven-tenths (2.7) acres. Together with the buildings thereon and including the log cabin on or near this lot. Reserving to the grantor herein, the right to use water for domestic purposes from the well located on the lot herein conveyed.
