the receipt whereof I do hereby acknowledge, do hereby give, grant, bargain, sell and convey, unto the said

A certain lot or parcel of land in the town of Livermore Falls, Androscoggin County, Maine, bounded and described as follows:

A strip of land four hundred (400) feet in width extending from my northerly to my southerly line and bounded northerly by the Severy lot, so-called, at the road; easterly by a line parallel with and sixty-two and one-half (62 $\frac{1}{2}$ ) feet easterly of a survey line now staked out across my lot, the Severy lot and the Clary lot; southerly by land now or formerly of Birchard A. Clary; westerly by a line parallel with and three hundred thirty-seven and one-half (337 $\frac{1}{2}$ ) feet westerly of the survey line above mentioned.
