the receipt whereof I do hereby acknowledge, do hereby give, grant, bargain, sell and convey unto the said

CENTRAL SECURITIES CORPORATION

and its successors and Assigns forever,
A certain lot or parcel of land in the City of Lewiston, Androscoggin County, Maine, on the northerly side of the Dyer Road, bounded and described as follows:

Northerly by land now or formerly of Erlon J. Dingley; easterly by a line parallel with and sixty-two and one-half (62 $\frac{1}{2}$) feet easterly of the survey line now staked out; southerly by the Dyer Road above mentioned at land now or formerly of Walter Tozier; westerly by a line parallel with and three hundred thirty-seven and one-half (337 $\frac{1}{2}$) feet westerly of the survey line above mentioned. Containing about six (6) acres.

Said lot being a portion of the same property conveyed to me by deed from John E. McCarthy dated April 11, 1927 and recorded in Androscoggin Registry, Book 387 , Page 282 .

Reserving to the grantor herein, an easement or right
of way beyond the above described parcel of land, not to exceed
twenty (20) feet in width and to be located by the grantee in
some location convenient for the said grantor and which will not
however, interfere with the use of the said above described parcel
by said grantee, or in connection with the transmission of
electric current.

forever.
