KNOW ALL MEN BY THESE PRESENTS,

That I, HARRY W. CLARK

of Lewiston County of Androscoggin and State of Maine, in consideration of one dollar and other valuable consideration paid by CENTRAL MAINE POWER COMPANY, a corporation duly organized and existing under and by virtue of the laws of the State of Maine and having an office and place of business at Augusta, County of Kennebec, said State of Maine, the receipt whereof is hereby acknowledged, do hereby give, grant, bargain, sell and convey unto the said Central Maine Power Company, its successors and assigns, forever, a certain lot or parcel of land in the city of Lewiston, County of Androscoggin, State of Maine, bounded and described as follows:

A strip of land 250 feet in width extending from land of Alban B. Hyde northwesterly to the state road leading from Lewiston to Augusta via Winthrop at land of Alban B. Hyde. Said strip being bounded northerly by said state road at the Hyde lot; northeasterly by a line parallel with and 50 feet northeasterly of the survey line now staked out across this lot, the Furbush lot and the Hyde lots; southerly and southeasterly by the Hyde lot; southwesterly by a line parallel with and 200 feet southwesterly of the survey line above described.

Excepting from the above any portion of the Edward C. Furbush lot within the boundaries of said 250 foot strip.

My title to the above property was derived as follows:

By deed from Anna J. Hyde.

Reserving to the grantor herein, an easement or right of way across the above described parcel of land for lumbering and agricultural purposes not to exceed 20 feet in width and to be located by the grantee in some location convenient for the said grantor and which will not, however, interfere with the use of the said above described parcel in connection with the transmission of electric energy.
