the receipt whereof I do hereby acknowledge, do hereby give, grant,
bargain, sell and convey, unto the said

CENTRAL SECURITIES CORPORATION

and its successors and Assigns forever,
A certain lot or parcel of land in the Town of Durham, Androscoggin
County, Maine, bounded and described as follows:

A triangular lot of land bounded easterly by a line parallel
with and sixty-two and one-half (62 $\frac{1}{2}$) feet easterly of the survey
line now staked out; bounded southerly by land of Clyde L. Hall;
westerly by land of Albert A. Walker and Andrew Dion. Said triangular
lot being located at the southwest corner of my land.

The above parcel being a portion of the land conveyed to me
by David Stackpole by deed dated May 24, 1897 and recorded in Andros-
coggin Registry, Book 171, page 536.

Reserving to the grantee herein the wood and timber
on said strip, the same to be removed at the request
of the grantee in season to avoid interference with
construction, or if not so removed, the grantee reserves
the right to cut, or cut, remove and dispose of
the same at its option.
