the receipt whereof I do hereby acknowledge, do hereby grant, bargain, sell and convey, unto the said

CENTRAL SECURITIES CORPORATION

Its Successors Heirs and Assigns forever.

A certain lot or parcel of land in the Town of Pownal, Cumberland County, Maine, southerly of the highway leading from North Pownal to New Gloucester and bounded and described as follows:

Northerly by land now or formerly of Leon R. Carleton, et al; easterly by a line parallel with and sixty-two and one-half (62 $\frac{1}{2}$) feet easterly of the survey line now staked out across my land and said Carleton lot; southerly by land now or formerly of Leon R. Carleton, et al. The above lot being triangular in form and containing about two and one-half (2 $\frac{1}{2}$) acres.

The lot herein conveyed being a portion of the same property conveyed to me by deed from Walter B. Arey, being Administrator of the Estate of Abbie M. Sawyer, dated November 21, 1927 and recorded in Cumberland Registry, Book 1275, Page 422.

Reserving to the grantor herein the wood and lumber on said parcel, said wood and lumber to be removed by the grantor on written request of the grantees. Or, if not removed by the grantor in season to avoid interference with construction or maintenance work, the grantees may cut, or cut, remove and dispose of said wood and lumber at its option.

and will Warrant and Defend the same to the said Grantee, its Successors

Heirs and Assigns forever, against the lawful claims and demands
of all persons.
