# Know all men by these Presents,

That I, ZEPHIRIN DUBE, of Lewiston, Androscoggin County, Maine

in consideration of One Dollar and other valuable consideration

paid by the CENTRAL SECURITIES CORPORATION of Augusta, Kennebec  
County, Maine

the receipt whereof I do hereby acknowledge, do hereby give, grant,  
bargain, sell and convey, unto the said

CENTRAL SECURITIES CORPORATION

its successors ~~Maxx~~ and Assigns forever,

A certain lot or parcel of land on the southerly side of the River  
Road, so-called, in said Lewiston, bounded and described as follows:

Said lot being a strip of land four hundred (400) feet in width  
extending from the River Road southerly to the Androscoggin River  
and bounded easterly by a line parallel with and sixty two and one-  
half feet easterly of the survey line now staked out across said  
property, and by land now or formerly of Wilfred Dube; southerly by  
the Androscoggin River; westerly by a line parallel with and three  
hundred thirty-seven and one-half (337 $\frac{1}{2}$ ) feet westerly of the survey  
line above mentioned. Containing about thirty-eight (38) acres.  
This lot is bounded northerly by the River Road, so-called.

Said lot being a portion of the same property conveyed to me  
by deed from Romeo Pomerleau dated Oct. 14, 1924 and recorded  
in Androscoggin Registry, Book 346, Page 506.

Reserving to the grantor herein, an easement or right of way across the above described parcel of land, not to exceed twenty (20) feet in width and to be located by the grantee in some location convenient for the said grantor and which will not however, interfere with the use of the said above described parcel by said grantee, or in connection with the transmission of electric current.

To have and to hold the aforegranted and bargained premises, with all the privileges and appurtenances thereof to the said
