



P12-1: Savade Pond Boat Access, ME IF&W. Cooper's Mill Substation is located 1.5 miles to the southeast. Modifications to the Substation for the Project will not be visible from this location.



P12-2: Windsor town center at the intersection of Ridge Road and Route 105. The Project will not be visible from this location.



P12-3: Panoramic view looking from Coopers Mill Road in Windsor towards the Cooper's Mill Substation and existing transmission lines. Upgrades to the Substation for the Project will be located on the north side of the existing facility. The additional components will be minimally visible from Cooper's Mill Road.



P12-4: View looking west on Maxcy's Mill Road in Windsor. The proposed 345 kV transmission line will be constructed in between the two existing transmission lines. No additional tree removal is required.



P12-5: View looking south on Griffin Road in Windsor. The proposed 345 kV transmission line will be constructed in between the two existing transmission lines. No additional tree removal is required.



P12-6: Panoramic view looking northeast on Route 32 (Ridge Road). The existing transmission line visible is not part of the Project. The Project will not be visible from here due to intervening vegetation.



P12-7: Panoramic view from Route 32 in Windsor from north to northeast. The proposed 345 kV transmission line will be constructed in between the two existing transmission lines. No additional tree removal is required.



P12-8: Panoramic view looking east from Baker Road in Windsor. The proposed 345 kV transmission line will be constructed in between the two existing transmission lines. The existing buffer will remain because no additional tree removal is required.



P12-9: Municipal Conservation Land, Whitefield. The Project will not be visible from this location.



P12-10: Panoramic view looking west from the village of Coopers Mills, Whitefield. The Project will not be visible from this location.



P12-11: Panoramic view of Long Pond from the Barton public boat launch toward an existing transmission line - not related to the Project. The Project will not be visible from this location.



P12-12: Looking north toward Travel Pond from Route 32 in Jefferson. The Project will not be visible from this location.



P12-13: Whitefield Salmon Preserve parking and trail head, Whitefield. The Project will not be visible from this conservation area.



P12-14: Whitefield Salmon Preserve, Whitefield. The Project will not be visible from this conservation area.



P12-15: View looking southwest from Cooper's Road. The proposed 345 kV transmission line will be constructed in between the two existing transmission lines. No additional tree removal is required.



P12-16: National Register of Historic Places: St. Denis Catholic Church, Whitefield. The Project will not be visible from this structure.



P12-17: View from Gardiner Road/ Route 126 looking northeast, Whitefield. The proposed 345 kV transmission line will be constructed in between the two existing transmission lines. No additional tree removal is required.



P12-18: National Register of Historic Places: Whitefield Town Office, Whitefield. The Project will not be visible from this structure.



P12-19: Happy Farm River Trail conservation land. The Project will not be visible from this area.



P12-20: Uncas Farm historic structure, and Maine Farmland Trust conservation land, Whitefield. The Project will not be visible from this structure.



P12-21: National Register of Historic Places: Clary Mill. The Project will not be visible from this structure.



P12-22: Panoramic view of North Whitefield town center, looking north. The Project will not be visible from this location.



P12-23: View looking northwest from the boat launch on Clary Lake in Jefferson, 4.0 miles from the Project. Tips of one or two structures may be slightly visible from the eastern end of the lake. There will be no Project visibility from within 3 miles of the Project due to shoreline vegetation.



P12-24: Looking north on East River Road towards historic farmhouse, Whitefield. The Project will not be visible from this location.



P12-25: Sheepscoot Links Golf Course, Whitefield. The Project will not be visible from this location.



P12-26: Panoramic view looking east from Pittson Road toward view of existing transmission line, Whitefield. The Project will be visible over the open fields.





P12-27: Panoramic view looking east to south from Pittson Road (Route 194) toward the existing transmission line crossing, Whitefield. The proposed 345 kV transmission line will be constructed in between the two existing transmission lines. No additional tree removal is required. See Photosimulation in Appendix D.



P12-28: National Register of Historic Places: Moody Mansion, Pittson. The Project will not be visible from this structure.



P12-29: Whitefield Community Church, Whitefield. The Project will not be visible from this structure.



P12-30: National Register of Historic Places: Union Hall, Whitefield. The Project will not be visible from this structure.



P12-31: View looking east toward the Sheepscot River from bridge on East River Road/ Route 218, in Whitefield town center. No Project views.



P12-32: Panoramic view from Wiscasset Road/ Route 218 existing transmission corridor looking southwest, Whitefield. The proposed 345 kV transmission line will be constructed in between the two existing transmission lines. No additional tree clearing will be required.



P12-33a: View looking northwest toward the Sheepscot River from Head Tide Dam, Head Tide Historic District, Alna. The Sheepscot River is rated as a scenic river in the [Maine Rivers Study](#). The Project will not be visible from this viewpoint.



P12-33b: Head Tide Dam, Head Tide Historic District, Alna.



P12-34: Old Head Tide Church in Head Tide Historic District, Alna. The Project will not be visible from any structures within the District.



P12-35: View looking northeast on Head Tide Road, Head Tide Historic District, Alna. The Project will not be visible from any structures within the District.



P12-36 View looking northeast on Head Tide Road, Head Tide Historic District, Alna. The Project will not be visible from any structures within the District.



P12-38: View looking southwest from Hollywood Blvd in front of the Moses Carleton House, a structure on the National Register of Historic Places. The Project will not be visible from this location.



P12-37 View looking west on Head Tide Road, Head Tide Historic District, Alna. The Project will not be visible due to intervening topography and vegetation.
