



P3-1: Panoramic view looking southeast at the proposed HVDC transmission line crossing on Wilson Road, West Forks, Plt. Evidence of a timber harvesting lay down area visible on sides of the road.



P3-2: Panoramic view looking southeast at the proposed HVDC transmission line crossing on Fish Pond Road, Moxie Gore Twp. Evidence of a timber harvesting lay down area visible on sides of the road.



P3-3: Camper parked on Fish Pond Road near proposed HVDC transmission line crossing.



P3-4: House on Arctic Way near Fish Pond Road is 140'+/- from proposed HVDC transmission line crossing.





P3-5: Harris Dam on the south end of Indian Pond. The Project is located 1,900' +/- downriver from the dam.



P3-6: Existing transmission lines at the parking area for Harris Dam used by rafting companies for access.



P3-7: Access stairs used by rafting companies to access the Kennebec Gorge.



P3-8: Kennebec River: Viewpoint 1 looking looking south 0.9 miles +/- from Project crossing.





P3-9: Kennebec River: Viewpoint 2 looking looking south 1,700 +/- feet from Project crossing.



P3-10: Kennebec River: Viewpoint 3, at Picnic Area looking looking southwest from 900 feet north of the Project crossing. See Photosimulation in Appendix D.



P3-11: Kennebec River: Viewpoint 4 looking looking northeast 1,500 feet south of the Project crossing. See Photosimulation in Appendix D.



P3-12: Kennebec River: Viewpoint 5 looking looking south 1,900 +/- feet south of the Project crossing.





P3-13: Panoramic view looking west from Moxie Stream. The proposed HVDC transmission line crossing will be 550' +/- to the west of this viewpoint. See Photosimulation in Appendix D.



P3-14: Footpath entry on the north side of Moxie Stream at the Fish Pond Road access.



P3-15: Parking area at Moxie Falls.





P3-16: Signs at Moxie Falls Scenic Area.



P3-17: Walking trail to Moxie Falls.



P3-18: Moxie Falls. The Project will not be visible from the Moxie Falls Scenic Area due to intervening vegetation.





P3-19: Picnic shelters at Lake Moxie Road rest area.



P3-20: Pedestrian bridge over Moxie Stream near Lake Moxie Road rest area.



P3-21: Panoramic view looking northeast from shore of Lake Moxie Road rest area. The Project would be 3 miles +/- to the northeast of this viewpoint and will not be visible.





P3-22: View looking west toward the proposed HVDC Transmission line crossing on Lake Moxie Road, just east of Moxie Field Road intersection.



P3-23: Existing transmission corridor crossing Moxie Road 850' +/- from boat launch at Troutdale Road.



P3-24: Building character near Moxie Pond Boat Landing.



P3-25: Moxie Pond Boat Landing. The Project will not be visible looking south-east from this viewpoint.





P3-26: Aerial view of the existing 115 kV transmission line crossing Moxie Stream and Indian Pond Road to Harris Dam north of Moxie Pond.



P3-27: Aerial view of the existing 115 kV transmission line on west side of Moxie Pond.



P3-28: Panoramic view from Moxie Pond looking west toward Black Narrows and Mosquito Mountain. The majority of the proposed co-located HVDC structures will be screened from this area on Moxie Pond by shoreline vegetation.





P3-29: Panoramic view from Moxie Pond looking southwest toward Black Narrows and Mosquito Mountain. Tops of approximately four proposed HVDC structures will be visible from this location at the base of Mosquito Mountain.



P3-30: Panoramic view looking northwest toward Mosquito Mountain from the south end of Moxie Pond. Three proposed HVDC structures will be visible from this location where the existing transmission line is visible. Moxie Pond is a designated scenic resource with a 'Outstanding' rating in the Maine Wildlands Lake Assessment. See Photosimulation in Appendix D.





P3-31: Boat put-in near south end of Moxie Pond.



P3-32: View of the existing transmission line corridor at clearing near Troutdale/ Trestle Road at south end of Moxie Pond.



P3-33: Troutdale Road in vicinity of the Mosquito Mountain trailhead.



P3-34: Trailhead marker at the base of Mosquito Mountain on Troutdale Road.





P3-35: View of existing 115 kV transmission line from the trail to Mosquito Mtn. The proposed co-located HVDC transmission line will be visible on west side.



P3-36: View of overlook east of the summit on Mosquito Mountain.



P3-37: Panoramic view from summit of Mosquito Mountain looking north. The north end of Moxie Pond and Indian Pond Road within the existing 115 kV transmission line are visible on right side of image.





P3-38: Boats near the shoreline at the Mosquito Pond put-in, The Forks Pt.



P3-39: Evidence of timber harvesting lay down area visible on side of Mosquito Pond Road.



P3-40: Panoramic view from Mosquito Pond looking east toward the proposed HVDC transmission line. Mosquito Pond is a designated scenic resource with a 'Outstanding' rating in the Maine Wildlands Lake Assessment. The Project will not be visible from the pond.





P3-41: Panoramic view from Black Brook Pond , Moxie Gore, looking southwest toward Project. The Project is 3 mi. +/- from this location and will not be visible.



P3-42: View looking southwest from Knight's Pond, Squaretown, Twp. The Project will not be visible from this pond.



P3-43: View looking west from shoreline of Baker Pond. Coburn Mountain at 14 mi beyond. The Project will not be visible from this pond.





P3-44: View looking southeast at Fish Pond boat access. The Project will not be visible from this pond.



P3-45: Looking south across Moxie Stream approximately one mile north of the proposed Project crossing. The Project will not be visible from this location.



P3-46: Panoramic view from Prescott Pond looking north, Moxie Gore Twp. The Project will not be visible from the pond due to intervening vegetation.
