

Good morning Jerry, Would you (and perhaps Jim too?) be willing to sit down w/ me and Sally Stockwell soon after March 6 to discuss NECEC? Briefly: As you might imagine, Maine Audubon is looking at NECEC primarily through through a wildlife habitat lens. We've engaged in an extended back-and-forth with CMP, encouraging them to go "above and beyond" the letter of the law in order to truly account for the project's impacts - or better yet, to take steps to avoid or minimize those impacts. Thus far, we've not seen any indication of progress.

We would welcome the opportunity to share our concerns with you and to perhaps gain insight into progress we're not yet aware of.
