## **25.0 PUBLIC NOTICE**

On January 13, 2022, a combined Notice of Public Informational Meeting and MDEP/LUPC Notice of Intent to File (notice) was sent to abutters, the Towns of Benton and Clinton, and additional LUPC recipients by Certificate of Mailing. The notice was also published in the Waterville Morning Sentinel and Kennebec Journal on January 14, 2022. See Exhibit 25-1 for a copy of the public notice, as sent to abutters and as published, and the signed Public Notice Filing and Certification form. See Exhibit 25-2 for the notice mailing list.

Due to the COVID-19 pandemic, the Public Informational Meeting was held virtually on the evening of January 25, 2022. The Applicant consulted with MDEP on the format of the meeting prior to scheduling, which included both telephone and online participation options. The Applicant presented background information on the Project, impacts to environmental resources, cultural resources, visibility, noise, and economics. The Applicant answered questions about the Project and discussed the Project with meeting participants. An overview informing the public of means to participate in MDEP's licensing process and the required state, local, and federal licenses necessary for the Project was provided in the meeting and was available via the Project's website<sup>1</sup> prior to the meeting. Public participation information and the Project's anticipated environmental impacts were posted to the Applicant's website in advance of the meeting. Eight members of the public were in attendance. Attendees were primarily interested in details regarding Project noise and any changes at the Albion Road substation.

A request for a LUPC public hearing on the request for certification and/or a petition for leave to intervene in any such hearing must be received by the LUPC in writing no later than 20 days after the request for certification is found by the LUPC to be complete and accepted for processing. The LUPC will consider the degree of public interest when determining whether to hold a public hearing, but the decision whether to hold a hearing is at the LUPC's discretion.

If the LUPC holds a public hearing, members of the public also may offer testimony at the hearing without formally intervening in the hearing, and/or may submit written comments until the close of the record. A request or petition that is not timely filed will be denied unless the requestor/petitioner shows good cause for failure to file on time. TO: All Interested Persons DATE ISSUED: January 12, 2022

As required by Section 6 of the State of Maine Rules Relating to Drinking Water State Revolving Loan Fund Chapter 230, the Department of Health and Human Services (DHHS) staff prepared a "Justification for Categorical Exclusion" on behalf of Kennebec Water District of Waterville, Maine to exempt a proposed project from the formal environmental review requirements.

The proposed action is to upgrade the existing water treatment plant (WTP) site and chemical storage facility. Site improvements include repaving the existing parking lots and expanding the existing parking lot towards the south side of the building by approximately 230 SF. All work is to be on property currently owned by the District at their Water Treatment Plant, 462 Main Street in Vassalboro, ME.

The Drinking Water Program's review of the proposed actions has indicated that it meets the criteria of "Categorical Exclusion" listed in subsection c (1) of Chapter 230. The project is not likely to have significant effects on the quality of the environment. Specifically, the proposed action is the upgrades to an existing drinking water treatment plant owned by the Kennebec Water District.

Therefore, a Categorical Exclusion from formal environmental review as provided in Section 6 of the State of Maine Rules Relating to Drinking Water State Revolving Loan Fund Chapter 230 is being granted. This exclusion may be revoked at any time if 1) the project is altered and no longer meets the requirements of a categorical exclusion 2) new evidence shows that serious environmental issues exist or 3) a local, State or Federal law is being or may be violated.

Project documents are on file and are available for public review at the offices of the Kennebec Water District and the offices of the Drinking Water Program. Comments relative to this decision may be submitted to the Department of Health and Human Services Drinking Water Program.

Their names and addresses can be obtained from the town tax maps or local officials. They must receive notice within 30 days prior to the filing of the application with the Department.
3. **Municipal Office:** You must send a copy of the Notice of Intent to File and a **duplicate of the entire application** to the Municipal Office.

**ATTACH a list of the names and addresses of the owners of abutting property.**

### CERTIFICATION

By signing below, the applicant or authorized agent certifies that:

1. A Notice of Intent to File was published in a newspaper circulated in the area where the project site is located within 30 days prior to filing the application;
2. A certified mailing of the Notice of Intent to File was sent to all abutters within 30 days of the filing of the application;
3. A certified mailing of the Notice of Intent to File, and a duplicate copy of the application was sent to the town office of the municipality in which the project is located; and
