I am opposed to any and all parts of the EV sales rule. Not only should it be illegal for an unelected board to mandate such restrictions, it is anti-democratic to regulate and restrict consumer choice in such a way. By passing this rule, you are interfering with the free market which should instead be driven by consumer demand. The Maine public clearly is NOT interested in purchasing EVs, as current sales prove. Maine people have common sense. Not only are EVs overpriced, but they are unreliable in cold weather, do poorly in hilly areas, and are totally unsuitable for long distances that people in a rural state like Maine must travel, despite the attempts of EV proponents to convince us otherwise. I do not want to be stranded somewhere in freezing cold (or any kind of)weather, because of lack of reliable charging stations, batteries that cannot hold enough charge to get me where I am going, or any other reason EVs can fail. I do not want my children or grandchildren to ride in these vehicles. The batteries are dangerous and can ignite in a garage or near a home. We need to stop trying to replicate California rules. Maine is NOT California, and we DO NOT want to be. Please stop this terrible ruling now, or I predict a statewide referendum <u>will succeed</u> in repealing this unjust California-copied EV rule. There will not be a problem obtaining the referendum signatures, of that you can be certain.
