Speaking of roads, we have a gas tax that helps with the maintenance of our roads. Where is funding going to come from for that? Might that add some cost to our already over used over priced grid?

Finally, I would like to say that I don't like mandates. This is a mandate on car dealerships and consumers that will not end well. Maine is not a wealthy state and many consumers will not be able to afford the electric cars. The dealerships are going to end up having a lot of useless inventory that they will have to discount to move which in the end will result in many to having to close. There goes free enterprise and competition!

Please put this issue on hold and revisit it once we are in a position to make the transition in a positive way. Don't impose mandates on the citizens of Maine that will result in hardships.
