100% EV is crazy for this climate, and actually crazy to do regardless for the following reasons:

1. Our electrical grid (state and national) is out of date to handle the demand. How do you expect our state to meet the demand when your administration does what is can to not allow it to be generated efficiently, like via nuclear.
