Standards for Permit-by-Rule for Beneficial Use of Tires in Structures.

The use of whole tires in structures may receive a permit-by-rule when all of the following standards are met. Proposed beneficial uses of tires in structures which do not meet these standards may apply for a license under the provisions of 06-096 C.M.R. ch. 418, section 9.

- (1) No more than 1,000 whole tires (each having a maximum rim size of 25 inches in diameter) may be used on the parcel of property covered by the permit-by-rule.
- (2) The term of the license is 3 years, during which the construction shall be completed.
- (3) Tires may not be placed in standing water or in a channeled drainage flow. Tires may not be used to fill wetlands, or be placed below the water table or in any water of the State.
- (4) Tires intended to be used for a project may be stored in a secure location near the project that is under the control of the licensee. All excess tires must be removed from the project area upon completion of the project.
- (5) Annual reports must be filed for each year during the term of the license. The reports must include both the quantity of whole tires used on the property and the quantity of whole tires stored on the property at the end of the calendar year, and verification that tires were used as proposed in the application.

REQUIRED INFORMATION FOR A PERMIT-BY-RULE FOR BENEFICIAL USE OF WHOLE TIRES IN STRUCTURES

Notification Package Requirements. At least 24 calendar days prior to the initiation of the proposed activity or use an applicant shall submit a signed permit-by-rule notification on this form provided by the DEP. The permit-by-rule notification package must include:

- **1.** All information required on page 1 of this application form.
- **2.** Information that demonstrates sufficient title, right or interest to property where the proposed activity will occur, as specified in 06-096 C.M.R. ch. 2, section 11(D).

3. A description of the proposed use of tires, including information on the type of structure to be constructed with tires.

- 4. An estimate of the number of whole tires proposed to be used in the structure.
- **5.** The most recent full size U.S. Geological Survey topographic map (7 1/2 minute series, if available) of the area, clearly marking the project location. GPS coordinates for the activity shall be provided in the project description.
- **6.** Information in sufficient detail to describe how tires will be placed to build the proposed structure.
