The Department provides health care and social services to approximately a third of the state's population, including children, families, older Mainers, and individuals with disabilities, mental illness and substance use disorders. The Department also promotes public health through the Maine Center for Disease Control and Prevention, operates two state psychiatric hospitals, and provides oversight to health care providers through the licensing division. As the largest Department, we employ 3,200 people dedicated to improving the health and wellbeing of our residents.
