TP = Treatment plant-Collect the sample after all treatment at the entry point into the distribution system

WL = Well-Collect a raw water source sample before any treatment and before any water storage tanks

EP = Entry point-Collect the sample at the entry point into the distribution system

MN = Manifold-Usually the location where one or more sources of water are combined together

IN = Raw water intake-For a surface water system

DS = Water System Distribution

-If you are on quarterly DBPs per the Stage 2 DBP Rule, collect within your designated month (every 90 days).
