

Minutes of Meeting #135 Nov 30, 2016

The Maine Public Drinking Water Commission (DWC) held its 135th meeting on Nov 30, 2016 at the Kennebec Water District, Waterville Maine.

Time: Jeff called the meeting to order at 9:10 AM

A. APPROVAL OF MINUTES:

Minutes from the last meeting were approved as written.

B. RECURRING BUSINESS:

1. SFY 2017 AFM FEE COLLECTION STATUS

Roger presented the AFM Fee revenue status. The collection rate was at 97.1 percent for a total \$499,526 collected which is on par from previous years. Roger stated that spending for the 2017 SFY is in agreement with the budget.

2. LEAD IN DRINKING WATER UPDATES

Roger discussed the collaboration between schools, municipal water systems, and the Drinking Water Program regarding lead testing in schools.

3. DWP STAFFING UPDATE/STAFF MERIT AWARD

The DWP has received permission to fill the Public Water Inspector position in the Bangor office, the Rule Specialist position in Augusta (Jenn Grant's position) and the Source Water Protection Coordinator (formerly known as Education and Outreach Coordinator Erika Bonenfant's position) in Augusta. Interviews are currently in process for the vacant hydrologist. Roger stated we hope to be fully staffed by middle of January 2017.

Jeff indicated that the winner of this year's Staff Merit Award which was Terry Trott.

4. DWC MEMBERSHIP UPDATE - REAPPOINTMENT STATUS

Harvey Chesley's seat expired August 2016. Jim will follow up with Governor's office to see if Harvey has re-applied and Roger will follow-up with Harvey.

Maine Drinking Water Program Alternative Funding Mechanism Five Year Budget Projection


