COVID-19 VACCINATION TRAINING AND EDUCATION

Summary: On December 11, 2020, the U.S. Food and Drug Administration issued an [Emergency Use Authorization](#) for use of the Pfizer-BioNTech COVID-19 vaccine in persons aged 16 years and older for the prevention of COVID-19.

On December 12, 2020, the [Advisory Committee on Immunization Practices \(ACIP\)](#) met to discuss a recommendation for the use of Pfizer-BioNTech's COVID-19 vaccine for the prevention of COVID-19. U.S. CDC CLINICIAN OUTREACH AND COMMUNICATION ACTIVITY (COCA)

What Every Clinician Should Know about COVID-19 Vaccine Safety

The COCA call will be available for viewing on the [COCA website](#) a few hours after the live event ends.

Overview: Clinicians will learn how they can educate their patients about what to expect after COVID-19 vaccination. In addition, they will learn how they can play an important role in monitoring the safety of COVID-19 vaccines. This includes encouraging patients to enroll in v-safe, a new smartphone-based, after-vaccination health checker for people who receive COVID-19 vaccines, and to use v-safe to report how they're feeling. Clinicians also will learn how to report adverse events (possible side effects) to the Vaccine Adverse Event Reporting System (VAERS).
