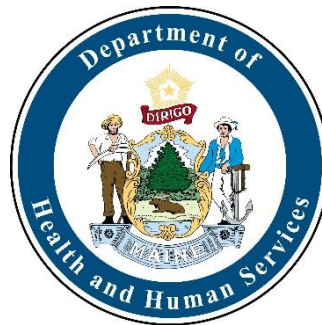

Allocations

- Consistent Allocations for the next 3 weeks
 - 16% increase
 - will be consistent for the next 3 weeks
 - presentation has not yet been determined
- Population based allocation model
 - Consistent with how we have been previously allocated vaccine

- Data quality
 - Date of Administration instead of Date of Birth
 - Current Year instead of Year of Birth
 - Non-Specified Dose
 - This results in a non match for 2nd dose complete
