Please note the correction on the dosage for children 6 through 35 months.

For the 2015-2016 influenza season, the Maine Immunization Program is providing vaccine for all Maine children, ages 6 months through 18 years. ACIP recommends annual influenza vaccination for everyone 6 months and older with either mist or injectable vaccine, with no preference expressed for either when either is appropriate. MIP will not be providing **adult** influenza vaccine this season.

Not sure about the number of doses?

Is your patient between 6 months and 8 years? If so, please follow these guidelines:

- Patient has had TWO doses of flu prior to July 1, 2015, whether in the same season or not: they receive ONE dose of 2015-16 flu.
- Patient has had ONE dose of flu prior to July 1, 2015: they receive TWO doses of 2015-16 flu.
- If the child receives one dose at age 8 and turns age 9 before the second dose, the second doe is NOT recommend.

Appropriate?	LAIV	IIV
Yes	ANY person ages 2 years through 49 years	Appropriate for ages 6 months and up but varies depending on the <u>manufacturer's</u> age guidelines
No	Several groups. Here are a couple but the full list can be found on the CDC Website: -ANY person UNDER 2 years or OVER 49 years -A person with a contraindication, which may include taking aspirin -History of egg allergy -Pregnant	-See table above for MIP recommended age groups
