Did you remember to calibrate your data loggers? Sign up to receive automatic reminders

Data loggers and other approved temperature monitoring devices must have current dates of calibration in order to meet CDC requirements. A designated person should be in charge of ensuring that this step has been taken.

We understand that provider sites are busy and remembering to calibrate thermometers is often a step that is forgotten. By sending the following information to Control Solutions, you will receive automatic NIST re-certification notifications.

DTaP, Tdap and Td Catch-up Schedule

Getting a child who has fallen behind on immunizations caught up with vaccination requirements can be a challenging.

Children age 7 years or older with an incomplete history of DTaP should be given Tdap as the first dose in the catch-up series. For these children, an additional adolescent Tdap should **not** be given. A series of three Td-containing vaccines should be given to complete a catch-up series. Below are examples of different scenarios that may arise in your practice:

Example # 1: An 8-year-old has only received one dose of DTaP. To complete their series they will need:

One dose of Tdap

▼

Four weeks

▼

One dose of Td

▼

(One dose of Td every ten years thereafter)

Example # 2: A 10- year-old has never been immunized, but mom decides to start now. To be fully protected and in compliance with school requirements, they will need:

One dose of Tdap

Four weeks

One dose of Td

Six months

One dose of Td
