

PREVENTING CANCER JUST GOT EASIER

HPV vaccine protects against cancers and other diseases caused by human papillomavirus (HPV). Follow the HPV decision tree chart below to determine whether your patient needs two or three doses of HPV vaccine.

ImmPact Request Vaccine Usage Link

The Request Vaccine Usage Report provides

information on how many doses of each vaccine have been given by age, within a specified date range. Providers may use this as a tool to estimate how much vaccine to order which will help in preventing over ordering and wastage. Providers can also use this link to see what they administered during any time period.

Instructions:

- 1. Log into site.
- Under the "Inventory" heading, choose the 2. "request vaccine usage" link.
- 3. You will come to the "Vaccine Usage Report Criteria" screen.
- 4. Choose the site from drop down. Enter the date range interested in.
- 5. Click *generate* report. (Example 1)
- 6. Click the *refresh* tab until 100%. This usually only takes one click.
- 7. Click the blue link under Report Name.
- 8. Vaccine Usage Report opens. (Example 2)
