**Families** with children from birth through age 21 that have, or are at risk for:

- chronic medical conditions
- behavioral and emotional conditions

# Family Support Navigator Maine Parent Federation (MPF)

# **EPSDT**

## Early and Periodic Screening, Diagnostic and Treatment (EPSDT)

- Federally mandated service to provide preventative and comprehensive health services for Medicaid-eligible children.
- The purpose of EPSDT is to discover and treat childhood health conditions before they become serious or disabling.
- Serves children from birth to age 21.

## Requirements:

- For billing purposes, it may require a Prior Authorization or additional documentation
- Medically necessary (not experimental)
- Not described or covered by any other MaineCare regulation.
- Exceeds in frequency or duration covered by other regulation.
- Cannot be custodial, academic, educational, vocational, recreational, or social.
