What can I do? You can contact the Maine CDC WIC Nutrition Program to discuss your ineligibility and/or request an administrative hearing. In an administrative hearing you can tell why you think you were not treated fairly. You tell your reasons to an Administrative Hearing Officer who does not work for the WIC program.

How do I ask for an administrative hearing? You or your representative may ask for an administrative hearing by signing and returning this form to the Hearing Examiner, Policy and Compliance, Maine Center for Disease Control and Prevention, 286 Water Street, 8th Floor, 11 State House Station, Augusta, Maine 04333-0011. The request must be received within sixty (60) calendar days from the date of this notice. The Office of Administrative Hearings will schedule the hearing and send you a letter with the date, time and location of the hearing.

Who makes the decision at an administrative hearing? After listening to both you and WIC staff and reviewing program rules, the Hearing Officer makes a decision, on behalf of the Commissioner of the Department of Health and Human Services. Both you and the Maine CDC WIC Nutrition Program will be notified in writing of the decision, by mail, approximately thirty (30) days after the hearing is closed.

What can I do if I do not like the decision? You can appeal the decision within thirty (30) days for judicial review to the appropriate Superior Court.

I do not agree with the decision made by the WIC program and I request an administrative hearing.
