Subject: End of Comparable Formula & Abbott Similac Spit-Up discontinued

The WIC comparable formula waiver is scheduled to end February 28, 2023. The formula flexibilities that were implemented due to the formula recall in early 2022 will be removed and WIC participants will only be able to redeem WIC formula as prescribed in their benefit.

Also Similac for Spit-Up powdered sizes have been discontinued by Abbott.
