Bioterrorism, Chemical Terrorism, and Radiological Terrorism Triage Questionnaire


The Maine CDC Health and Environmental Testing Laboratory will not provide testing for substances and/or threats of a biological, chemical, or radiological nature unless a reasonable suspicion by a professional submitting the sample has been made.

Contact MEMA (800-452-8735), Poison Control (800-222-1222), 11th CST (207-877-9623) or Infectious disease epidemiology (800-821-5821) to coordinate the receipt of the sample. HETL (207-287-2727) can provide further guidance and must be contacted prior to delivery of the sample. Packaging and shipping must conform to the shipping and handling guidelines set forth by HETL, IATA, DOT and Federal CDC. HETL reserves the right to reject and or all samples that are not packaged properly.

If a potential threat has been determined, the following shall accompany the submitted sample, which must be no longer than a one-gallon paint can:

- HETL's Bioterrorism, Chemical Terrorism, and Radiological Terrorism Triage Questionnaire
- Submitters triage questionnaire
- Chain of custody form(s)
- All field testing result(s)
