City of Portland Update – Immigrant Health Screening Proposal: Alfredo Vergara, Director of Public Health, City of Portland	Alfredo shared the framework of a health screening that is being developed with local partners to specifically support immigrant populations. The health screening will help triage patients using a basic and minimal screening – pregnancy, chronic conditions, etc. The City of Portland hopes to develop a tool that can start small and simple; and build upon the tool as needs and infrastructure change. Their timeline is urgent, and they are in the process of getting an Electronic Medical Record (EMR) system in place.

	WIC is supporting dental clinics at UNE Dental School Thursdays from 8:30 am – 12:00 pm. This may change at the end of the school year but may evolve. Every fourth Thursday of the month, WIC in Portland partners with Presente! Maine to host Latinx families. Currently, the wait for a WIC appointment is extending out 6 – 8 weeks. They are seeing an uptick in pregnancies without prenatal care.
