9:10 – 9:44am **HUD Update**

Patty Hamilton will overview the process of closing the Kenduskeag Stream encampment following HUD technical assistance team guidance.

Need to offer them housing. Need to identify the structures, the people, the pets (behind Valley Avenue). Created a bi-name list. Once the people are identified, i.e. do they have a license, do they have a social security card, all these things need to be done before they can get housing. Fill out applications to get identified, letter for ADA needs, etc. Did this for a month or more. At this same time there was a landlord liaison. City kicked off a landlord liaison program, met with the secretary of the state (fast tracked a process to redo ids) while keeping a process for next time if needed. Got all the outreach workers laptops. Arranged with case worker to go see apartments. Emergency preparedness engagement. 15 people left when the encampment closed. Shelter Plus Care Vouchers, bridging rental assistance or social security, disability, general assistance (mandated service in the state, if you can get them to apply and go to the appointments). Housed 80%. Were able to put some into hotels, rooming houses, transition housing. Fast moving process and labor-intensive process. Purchased moving kits from Ann Sweeney (beds, small refrigerators, pots and pans, washcloths. Purchased phones so we could connect with them and maintain, i.e. vouchers. So far, this space has been kept unused, have not had any problems since this this. People are using for fishing. Now we have a robust system. Partners and supports. Even medial visits, MA to be able to take of their needs from suboxone to treating open wounds. Next step forward behind Hope House, larger encampment, higher levels of substance use disorders. Harder to get ready to close it.

Note: Bangor Area Action Team – mental health visit, ED, goes to dispatch to determine if it needs a police officer or not.




Data: Sites in Penquis District
