District Operations Update:

- Health Inspector Inspections would be done around the state if suspicions of a restaurants or tattoo parlor was not following the rules. No such suspicions have yet to be reported in Aroostook.
- PHN has been assisting Epidemiology
- DL/CDC is available for resource assistance &/or back up for people who may test positive for COVID-19.

- PPE Requests from Stockpile

- If requesting N95 to speed up the request

please clearly state that your organization has a respiratory program and has been respiratory cleared.

- Fit Testing
 - AMHC is having trouble getting someone to do the fit testing for staff.

- If you put in the request for fit testing now until approx. May 15th Darren W. will set your organization up to have the National Guard come and do fit testing.

- There are shortages and the best way to get what you need is to do an internal swap between organizations.
- Department of Corrections: Manufacturing face shields, cloth-based masks and PPE fit helmets
- Maine Janitorial (Caribou) has PPE Supplies (Gloves & Surgical Masks)

Joy Barresi Saucier, Aroostook Agency on Aging

- Remote operations continuing their services.
- Administrative support is in the office supporting the PSSs
- On a programming side there additional funding coming from the Federal and State Government. Funding will be used to strengthen the Home-Delivery program, increase virtual services provided, getting technology in the hands of clients who currently are isolated or in need of more regular virtual services.
- Increase in nutritional services being offered. Home-delivered meal program has increased to accommodate the homebound people over 60.

Jane Rioux, Northern Light Home Care and Health

- Currently seeing clients in a more modified virtual way.
- When needed home visits can be done. Staff is fit tested and NL HC&H has N95s
- Getting donations of clothe masks
- Teams available to respond to COVID-19 positive hospice patients should that be needed.

Ellen Bemis, AMHC

- In need of cloth masks for staff & residents at facilities. Trying to conserve & wash cloth.
- Peer recovery services offered online
- Therapy happening in expanded telehealth options. Hoping to continue this service after social distance rules are relaxed. Meeting with many people & increase in people attending meetings.
- Residential Treatment facilities are taking referrals. Strict admission screening for COVID-19 in place.

Tammy Hatch, Public Health Nursing

- Two PHN's working on investigations and assisting Epidemiology
- Two PHN's working with clients. Virtual Services have increased.
- PHN ready and available to support facilities in setting up respiratory protection plans.
- Working with 211. Eleven school nurses are going to be supporting 211 by answering clinical questions from the public.

- Update Submitted Post-meeting
- We are screening everyone who enters the facility, (staff and patients) for symptoms/ fever at the door. We have also implemented universal masking. Doing OK on supplies, continuing to get small shipments in. Smith and Wesson recently manufactured and donated over 1000 face shields that were split between the four county hospitals. The county hospitals have been meeting weekly to keep each other updated on what is going on at each facility. We are trying to encourage our community to take care of their other health care needs not covid-19 related by letting them know we are providing a safe place for them to receive health care with the safety measures we have implemented. We also have telehealth available for primary care. Our health services foundation director along with a team of employees here have also been working very hard to keep our employee morale up. Their efforts are being received wonderfully by the staff as everyone tries to make the best of these uncertain times.
