District Operations Update

Maine CDC- District Liaison Update

- 1. Maine is currently under a coronavirus surge, as is the County. The ME CDC is still classifying cases by outbreaks whenever possible, but we do have community transmission across all 16 of Maine's counties.
- 2. Governors new executive order reinforces the necessity of making in public places as well as limiting the number of individuals allowed for Indoor gathering back down to 50.

- 3. Increase in cases, hospitalizations, deaths, ICU admissions and ventilator usage.
- 4. Personal Responsibility If individuals are advised that they are COVID+ or have had close contact with a COVID + individual that necessitates isolation or quarantine, be proactive and follow the mandate right away. Take it upon yourself to remove yourself from circulation before the Maine CDC contact tracers must ask you.
- Influenza Vaccine best protective thing that we can do is encourage people to get themselves vaccinated for influenza. Encourage anyone who has not been immunized to do so.
