An application and attestation must be completed and submitted each year during the application period to determine continued eligibility. If certified, you are required to report to the Program if your practice location or any other condition of eligibility changes. The Program will confirm initial and continued eligibility requirements for each applicant upon receipt of a completed application every tax year. You must inform the Program if personal contact information or other information on this application changes within ten (10) days of actual knowledge of the change. Maine Revenue Services will receive confirmation of your certification.
