Dental Therapists Now Eligible for Federal Loan Forgiveness!

Exciting developments are on the horizon for Maine's dental health community. After years of advocacy and persistent efforts, dental therapists have now become eligible for federal loan forgiveness programs in states where they are licensed to practice. This recognition is especially significant as it opens up new financial support options for those providing essential dental care in underserved areas.

What are Dental Therapists?

Dental therapists have played an important role in oral health care around the world for over a century. Dental therapists are licensed providers that work under the supervision of a dentist and provide routine dental care, such as exams and fillings. They can work in traditional dental offices and clinics, or in community-based settings, such as schools or nursing homes. Dental therapists are a flexible and complementary addition to the dental team.

Dental therapists play a crucial role in bridging the dental health gap, particularly in rural areas with limited access to care. This new eligibility for loan forgiveness not only serves as an incentive for individuals considering a career in dental therapy but also promotes long-term retention of skilled dental professionals in rural communities. These dedicated professionals often work with vulnerable populations, providing preventive and restorative dental services. This policy change represents a major victory in expanding health care access, reinforcing Maine's commitment to equitable and accessible dental care.

New Data Analysis Dashboard: Tool for Rural Health Insights


We're excited to share the launch of the *New England Rural Data Analysis Dashboard*! This innovative mapping tool, developed by the New England Rural Health Association (NERHA) with funding from the six New England State Offices of Rural Health, is designed to illuminate rural health disparities across the region and provide actionable insights for rural health care improvement.

This dashboard offers access to nearly 200 rural health data elements across categories such as demographics, care utilization, insurance status, maternity services, social determinants of health, and more. Users can compare rural vs. urban disparities at state, multi-state, and regional levels, as well as explore variations by small rural, large rural, small non-rural, and core metro areas. With its ability to download data and generate PDF reports, this tool is invaluable for health care professionals, advocates, researchers, and students alike.

New England's rural communities are renowned for their resilience, tight-knit nature, and scenic beauty. However, these areas also face unique challenges, including significant health disparities compared to their urban counterparts. The dashboard sheds light on these differences, making it easier for decision-makers and advocates to address the needs of rural populations effectively.

From the White Mountains of New Hampshire to the

rugged coastline of Maine, this resource connects communities with data to better understand and tackle health inequities. Whether you're a rural health professional, policymaker, or student, the Rural **Data Analysis** Dashboard equips you with the tools needed to make
