Brief review of decisions and outcomes from Executive Committee and DCC meetings held since last SCC meeting. For agendas and copies of minutes, please see district's website at:

http://www.maine.gov/dhhs/boh/olph/lphd/index.shtml This quarter, the District Coordinating Council (DCC) met on October 26 at Snow Pond Center for the Arts, where we first heard an SCC update from our district SCC representative, then an infectious disease update from our district Field Epidemiologist; plus progress on our district health equity funding opportunity and with the district workgroups. The rest of the meeting was spent with Pat Kimball, Chair of the Maine Recovery Council, presenting on the Recovery Council's work and plans to distribute state opioid settlement funds, and getting input from the group.

Ongoing or upcoming projects or priority issues: District Health Equity funding disbursement, Hepatitis A prevention outreach, rabies, avian influenza; browntail moth; R-CHIP assistance with readiness and municipal priority assessment, PFAS and lead testing and remediation assistance, increasing housing and utility needs, DCC membership updates; Community Health Improvement Plan information and support; PPE and testing supplies navigation; vaccination clinic, appointment, and transportation assistance; assistance for and connection to organizations providing basic needs and resources, new LHO assistance.

Progress with District Public Health Improvement Plan (DPHIP): Activities planned for completion during the quarter and whether activities are able to be completed on schedule

- Use Central District Public Health Unit updates to communicate important information to DCC, LHOs, chief municipal officials, and partners -- ongoing task.
- Vaccination Coordination Workgroup has met monthly to address district needs and coordinate efforts
- The PCEs-Resilience Workgroup members are working on school and community supports for trauma and recovery, evaluating available tools, and collaborating on training

Successes achieved

- Input given on Maine Recovery Council Opioid Settlement funding disbursement planning and needs
- District Health Equity funding awarded to Winslow Community Cupboard for expansion

Barriers encountered

- Large amount of turnover in staffing at many organizations, and reduction in staff able to help with collaborative public health efforts
- End of financial supports due to federal funding running out

Structural and Operational changes, including updates in membership: added new Spectrum Generations Community Services Manager and additional Winslow Community Cupboard staff. Contractor has decided to keep Maine Prevention Network (MPN) Contract Advisory Board/Coalition separate from the DCC.

In-district or multi-district collaborations: Rural Community Health Improvement Partnership (R-CHIP) grant awarded to Spectrum Generations; COVID-19 and Influenza vaccination and testing information and assistance; prevention/basic needs assistance for organizations serving vulnerable populations; EMS service and non-profit organization testing assistance; transportation assistance; HRSA grant collaborations; Avian Influenza, PFAS, rabies, and browntail moth information and workshops.

Other topics of interest for SCC members: Pressing district needs right now for affordable housing, including recovery/supported housing, heating/utility assistance, and transportation services; along with respiratory illness prevention and supports for essential workers and their families.

In addition, this report was sent to us about the Maine Prevention Network (MPN) Contract Healthy Eating Active Living (HEAL) work accomplished during this quarter by the Maine CDC/DHHS Obesity Program Manager:

Ongoing or upcoming District projects or priority issues:

➤ Highlight completed activities conducted by Maine Prevention Network Contractor/ Subcontractors during September- November 2023:

- In collaboration with US CDC's DNPAO (Division of Nutrition, Physical Activity and Obesity) Strategic Communication Team, the central District shared monthly messaging on social media. Posts centered around healthy eating, indoor walking initiatives, breastfeeding education, Breast Cancer Awareness Month, StoryWalk trail updates, event updates, and more. HCCA's (Healthy Communities of the Capital Area) 24 Facebook posts had a reach of over 1823, with the top performing post reaching 424 users. HCCA's 12 Instagram posts had a reach of over 190 users, with the top performing post reaching 28 users. SPH's (Somerset Public Health) 30 messages reached nearly 3,500. Additionally, their walking initiative posts received a reach of 6,000 on social media and 1,000 through the Redington Fairview General Hospital's Employee Newsletter.
- Indoor walking and physical activity initiatives were implemented throughout the Central District. 10 Indoor Walking locations were confirmed in Somerset County from October 28, 2023 through March 29, 2024. HCCA established Manchester Elementary School as a Move More Kids 100 Mile Club site in partnership with RSU 38's elementary schools gym teacher. Additionally, they are partnering with the Maine General Community Health team to expand the program to the Northern Kennebec area.
- HCCA MPN team has been promoting and implementing Storywalk Initiatives. Current partnerships include Augusta Adult Education and the Kennebec County Youth Advisory Board.
- HCCA MPN HEAL staff created a data sharing system for school partners. This link will be shared to schools and regularly updated by all HCCA staff to promote programs in a more efficient way. This is now shared with 3 schools in Kennebec County to disseminate information.
- At SPH, 50 lbs. of fresh and frozen squash and eggplant were successfully delivered to Madison Elementary School as part of the school system's work and partnership between the Somerset County Jail and Madison Elementary School.
- SPH facilitated monthly school nutrition workgroup with school nutrition directors. Completed action plan, and reviewed Smarter Lunchroom objectives to implement in three districts.
- The Central District has been actively promoting their breastfeeding initiatives. HCCA HEAL coordinator has partnered with the MaineGeneral Lactation and Northern Light Lactation Teams in Kennebec County to promote breastfeeding education in the community. The SPH team Created and co-facilitated monthly RFGH's breastfeeding support and education workgroup. Reviewed MPINC (Maternity Practices in Infant Nutrition and Care) results, and created an action plan to assist with discharge support.

Ongoing or upcoming District projects or priority issues:

- ID/Epi is responding to on-going Hepatitis A cases
 - ID/Epi is working with federal CDC on two recent cases of salmonella
- Cumberland Field Epi is working with the Foodborne Epi and Liz Lamere, Maine CDC Epidemic Intelligence Surveillance officer, to publish a report on the pseudomonas outbreak at an indoor pool in Cumberland District, in the CDC's Morbidity and Mortality Weekly Report. Cumberland District field epi also submitted an abstract with the Vaccine Preventable Diseases epi to the NorthEast Epidemiology Conference in November that was accepted for an oral presentation
- Cumberland District Disease Intervention Specialist reports continued rises in STI rates.
- Cumberland DIS continues to call for sustained education for the public and providers to include syphilis testing in routine health exams, especially for pregnant people.
- > Two additional DIS positions were made available however, one is vacant again
- Since October 2023, 3 Boil Water Orders have been issued in towns in Cumberland County, as a result of presence of E. Coli. One Do Not Drink order was issued since October for a business in Cumberland County.

- MPHC Meeting: February 13, 2024, via Zoom, with a look at Maine Resilience Building Network (MRBN).

Ongoing or upcoming Public Health Council projects or priority issues:

- The Midcoast Public Health District (MPHC) has awarded the Public Health Infrastructure Improvement Grant to the County of Lincoln to improve their radio capacity for essential emergency ambulance service communication. The Lincoln County project will target a rural region and improve emergency response by supporting implementation of a dedicated Emergency Medical Services (EMS) radio channel.
- The MPHC meeting held on November 14th, 2023, focused on the Maine Prevention Network (MPN) work occurring within the Midcoast District. Presentations focused on Healthy Eating, Active Living (HEAL) Substance Use and Tobacco Prevention.

 - Mid Coast Hospital: September was a busy month for SUPS staff at MCH, especially as attendance at back-to-school events in our local school districts were in high demand. We attended both middle and high school open houses at Mt. Ararat, Richmond, and More school districts. Staff also attended learning opportunities with MYAN, webinars regarding various substance related topics, and community events and coalition meetings that allowed for networking.
 - Health Lincoln County (HLC): HLC's focus in September was the return to school and working with educators to plan and schedule primary prevention education in middle and high schools in Lincoln County. We kicked off the month with a film screening at the Lincoln Theater and the wrap up of our International Overdose Awareness Day event, 716 Candles. Post-event cleanup and preparation for an October 11th Community Debriefing for 716 Candles were required after the event.
