## **Minutes of Meeting**

#### **Introductions and Welcome**

- Danielle Day welcomed all members to Maine HCC-Downeast Chapter and took a moment to acknowledge the floods in Texas.
- Attendees were requested to put their names in the chat for attendance purposes, meeting was recorded for note taking purposes.
- A review of the previous meeting minutes was done and motion to accept them was called, approved by Andrew Sankey and seconded by Rod Tirrell, none opposed.
- The meeting agenda was presented and reviewed.
- A round of brief introductions of attendees was done.

# **HVA Report, Procedure and Workplan**, Al May, Danielle Day and Andrew Sankey

- An introduction of the purpose of the process to create a workplan and setting priorities were presented.
- An overview of the District HVA Procedure was presented and which data was used to set the priorities and create a workplan.
- The HVA analysis report for the Downeast was presented to the attendees which was reviewed to set the priorities.
- A small committee was formed of the Chair, Vice Chair, the district PHE and one Chapter member. The committee looked at the HVA analysis report, the work performed by the DEPHC Emergency Preparedness committee and the importance of Wildfires and Air Quality for the Downeast District to select the priorities and create the workplan.
- A survey was sent after the workplan was created to poll approvals from members.
- The action steps are suggested to be built in within the Downeast Chapter meetings, instead of creating an event specifically for the action steps.
- The plan intends to host subject matter expert for each priority and follow that with a tabletop exercise.

#### Wildfires, Ranger Martin Huysman:

- Ranger Huysman gave a brief introduction of himself and the department he works for. The department staffs 48 ranges, with 5 field rangers and 1 district ranger in the Downeast District.
- The rangers function is to cover wildfires, law enforcement related to wildfires and fires investigation if human element is suspected, they work closely and cooperatively with local fire departments such Acadia National Park, U.S. Fish and Wildlife, and others.
- They usually fall into command role based on the experience gained from working wildfires in Alaska and the West as Maine experience 1 to 2 significant wildfires a year, providing support with operations, logistics and medical sections.





## **Minutes of Meeting**

Wildfires...continued....

- Most modern healthcare facilities are impacted by smoke coming from fires, however rarely catch fires from wildfire flames as they are concrete, but there is a potential for heavy embers showers can build up in areas that are flammable such as corners, roofs, gutters, etc. that consist of wood materials, plant materials, etc.
- Firewise is a resource to help prepare buildings for wildfires, primary landscaping, what is called the ignition zone.

\*Ouestions:

**Andrew S.:** What are your roles and responsibilities with respect to wildfires in off-shore island areas?

**Martin H.:** In paper, with organized towns local fire departments are responsible for wildfires suppression until financial resources have been exhausted then the forest rangers takes charge. In the case of unorganized towns the forest service holds the primary responsibility in wildfires protection. Islands are at higher risk for wildfires as individuals burn stuff rather than properly disposing them because of costs. In case of a fire, the responsibility lies on the forest rangers, we utilize the marine patrol, local fishermen boats, construction and helicopters to move equipment and personnel to the islands. We also have evacuation capacity for healthcare facilities, in partnership with LifeFlight.

**Andrew S.:** What is the short haul program, where forest service meet with emergency medicine?

**Martin H.:** I am a short hauler, its a helicopter short haul rescue using a harness hooked to a rope below the helicopter, it is usually used for picking injured hikers. It is a unique tool to have and super versatile.

**Andrew S.:** Short hauler are more flexible in situations or conditions that are restrictive where LifeFlight can't operate. Martin H.: And we work closely with LifeFlight in providing support for transportation in areas where they can't land.

**Andrew S.:** What can individuals, home owners and facilities do minimize the risk of fires?

**Martin H.:** Landscaping, keeping anything that is flammable and the concentration of embers from dumpsters with cardboards, canoes against the side of a home with leaves under them, etc. We do also provide assistance and support prepping houses and clearing things out ahead of an impending fire.

**Brian F.:** (in chat) Do you have any preventative burns? **Martin H.:** Yes, we do conduct blueberry barrens under strict conditions and safety measures as they may expand and build up. There is an option through the state for funding and firewise grants to perform preventative burns for towns.

#### Maine HAN, Nate Riethmann:

- Nate is the Emergency Communications Systems Coordinator.
- The HAN is a messaging tool that can send emails, messages and initiate calls to members, that is capable of being customized to perform what is needed.
- It does not however provide geolocation alert, but the new system allows messages to be sent regionally based on an address or an organization.
- The system bombards you with messages until you reply with options on availability for a total of three contact attempts (once to each contact number/email you have listed).
- The HAN can be utilized by any organization, and they can be grouped into parent organizations and sub-groups or organizational units such as departments/facilities/branches, etc. with different rights for members: rights to send message and rights to manage users.

\*Questions:

**Shelly B.:** Calais Community Hospital was previously listed on the HAN, can we get CCH back into the system and add the sister hospital Downeast Hospital to the network in order to utilize it for emergency communications between hospitals and FOHCs?

**Nate R.:** Yes, Maine HAN is capable of doing that, it can be used to send messages to a subset within Calais hospital such as Incident Command or certain staff groups depending on the business rules.

**Rod T.:** How similar HAN is to Rave, can messages be sent without requiring a response from the recipient?

Nate R.: Yes.
