Maine CDC's TB Control Program

Tuberculosis (TB) is an infectious disease that can be treated and cured. As TB cases and rates are increasing, the State of Maine TB Control Program (TB Control) has put out the following guidance in an effort to reach the most people with our funds. TB Control is a flat funded program with the goal of helping all Mainers receive care for tuberculosis.

When to request payment from State of Maine TB Control Program

TB Control helps offset payments for the uninsured and/or underinsured TB patients who reside in Maine. All claims should be billed through the patient's primary and secondary insurance plans before being submitted to the program.

MaineCare Rates and Codes

In order to bill TB Control, facilities need to use appropriate CPT codes from the UCR list on the MaineCare website. TB Control may reject requests without CPT codes. Bills may take up to 30 days of processing time.

TB Control will only pay for necessary tuberculosis related care as the payer of last resort.

Named Close Contacts

TB Control will pay for the following up to two times within a 10 week period:

- Diagnostic Test (TST or IGRA)
- Chest X-Ray
- Doctor's visit

Active TB

TB Control will pay for TB related care for the duration of treatment.

Once diagnosed, TB Control can pay for related care that includes:

- medications
- doctor's visits and follow up appointments
- any procedures or care related to TB treatment

Non-pulmonary or miliary TB

In addition to everything listed under Active TB, TB Control may pay for related care on a case by case basis as some services may be necessary. Examples include:

- eye exams
- physical therapy

• additional x-rays An explanation of why additional services are needed and how they are related to the patients TB care is required.

Inactive TB (formerly LTBI)

TB Control will pay for medications for the duration of treatment.

TB Control will pay for the first office visit to get on treatment.

TB Control pays for medications listed on the formulary.

If a medication is needed outside this list, approval from a Maine CDC TB Consultant is necessary. Once approved it can be added to the specific patient formulary.

Standard of Care TB Control will pay for:

- Diagnostic tests up to 6 months prior to enrollment date.
- One-time pregnancy test before starting treatment.
- One-time eye exam prior to treatment; subsequent eye exams if eye problems occur due to TB related medications.
- For hospitalized patients: Room and Board and the procedures and care related to TB. TB Control will not pay for unrelated or additional procedures during the same stay.

TB Control will not pay for:

- Insurance copays
- Vaccinations
- STI testing
- Coincidental hospital procedures while undergoing TB treatment
- Procedures, treatments, or tests unrelated to TB
- Surveillance imaging after completion of treatment
