MaineCare uses the Bright Futures Standard of Care for Early and Periodic Screening, Diagnosis, and Treatment (EPSDT) program, which provides care for children from birth to 20. Using unique codes for each type of screening will permit use of claims data to reliably calculate relevant screening rates. - Providers of MaineCare Benefits Manual Sections 14 and 90 services will be reimbursed at the most current rates, which are found [online](#). Providers of services under other sections should contact Provider Services at (866) 690-5585 if they need assistance locating their fee schedules/reimbursement rates.
- CPT codes 96110, 96127, 99174 and 99420 can be billed on the same day as any Evaluation & Management (EM) CPT code without a modifier on the EM code; the National Correct Coding Initiative (NCCI) does not bundle payment for these services.
- CPT codes 96112 and/or 96113 cannot be billed on the same day as 96110, 96127, 99174, or 99420 for the same member.
- Federally Qualified Health Centers (FQHC), Rural Health Centers (RHC) and Indian Health Services (HIS) practices are to use these codes for encounter purposes; reimbursement for the visit will continue to be paid at the core rate for these practices.

***Modifiers:**

HI - Integrated mental health and mental retardation/developmental disabilities program

HK - Specialized mental health programs for high risk populations

HE - Mental health program

A provider administering a COVID-19 vaccine to a MaineCare member must be enrolled with both MaineCare and the Maine Centers for Disease Control (CDC). Providers must comply with all CDC requirements with respect to record-keeping, vaccine handling, and vaccine administration.
