## Schedule of proceedings:

## January 4, 2022 at 1:00 p.m., Remote Pre-hearing Conference:

This meeting will be held via Microsoft Teams to discuss the general administration of the hearing including the pre-filing of evidence, testimony time limits, and other considerations. This meeting is recommended for those who intend to apply for intervenor status. ## A. Registering to Participate

Due to COVID and capacity limitations, anyone wishing to attend the hearing is asked to register with DMR in advance so that space availability can be determined. <u>Persons intending to ask</u> **questions of the parties or testify about the proposed lease ("Interested Persons") must register with DMR to participate in this manner.** 

Interested persons must register no later than 4:00 p.m. on January 25, 2022. Failure to register may limit your ability to participate in the proceeding. ## B. Applying for Intervenor Status

Intervenor applications must be **received** no later than 4:00 p.m. on January 25, 2022. Intervenor applications must be requested from DMR at the contact information below. DMR will decide whether to grant intervenor applications five days before the hearing. If you apply for and are granted intervenor status, you become a legal party to the proceeding.

February 9, 2022 at 5:00 p.m., Hearing:

The hearing will be held at the date and time listed above at the: Bar Harbor Municipal Building (Town Council Chambers) 93 Cottage Street, Bar Harbor, 04609.

If the hearing listed above is postponed it may be held on February 10, or 17, 2022, as alternative dates, at the same time and location as the February 9<sup>th</sup> hearing. Notice of a continuance will be posted to DMR's website.

The hearing will be held in accordance with the adjudicatory proceeding provisions of the Maine Administrative Procedures Act (5 M.R.S.A., ch. 375, subchapter 4). Any interested person may attend the hearing and registered participants may ask questions of the parties or testify about the effect of the proposed lease.
