Shellfish Harvesting Area Classification-Notification of Changes

May 30, 2019

Ladies and Gentlemen:

Under the authority of 12 M.R.S.A. § 6172; the Commissioner has made the following classification change to Area No. 27-B, Lower St. George River (Cushing and St. George): This notice reclassifies Broad Cove (Cushing) from Prohibited and Restricted to Approved due to confirmation that a potential pollution source discovered during shoreline survey is not a public health concern and water quality meeting approved standards. All existing pollution and biotoxin closures remain in effect.


The boundary descriptions of the area are as follows (struck text is being removed and underlined text is being added):

- A. Effective immediately, because of pollution, it shall be unlawful to dig, take or possess any clams, quahogs, oysters or mussels taken from the shores, flats and waters of the following Prohibited areas:
1. Maple Juice Cove (Cushing): north of a line beginning at the south end of the point at Sheep Point Lane, Cushing, extending to the southern tip of the un-named point on the opposite shore.
 2. Maple Juice Cove (Cushing): inside of a line beginning at a red painted post on the west side of Burton Point, extending south to Green Can #7, then northeast to a red painted post on the east side of Burton Point.
 3. Gay Island, (Cushing): east of a line beginning at the most narrow portion of Gay Island, then running southwest to the southernmost tip of the unnamed point of land at the northeast end of Gay Cove.
 4. Deep Cove (St. George): inside of a line beginning at the western tip of the un-named point northeast of the point at the end of Crazy Point Lane then extending southwest to the tip of the point at the end of Crazy Point Lane then continuing southwest to the north end of Caldwell Island, then extending east to the point of land in Deep Cove at the end of Deep Cove Lane.
 5. The Narrows (St. George and Cushing): inside of a line beginning at the point of land at the northern end of Teel Cove (St. George), then extending north to the north tip of Hawthorne Point (Cushing), then extending east to the tip of the unnamed point at the end of Duncan Lane on Otis Point, St George.
 - ~~6. Broad Cove (Cushing): east of a line beginning at the shore at the end of Lewis Lane, Cushing extending northwest to a red painted post located at the south end of the most northern path on the prominent unnamed point opposite Fales Store, at the head of Broad Cove, Cushing.~~
 - 6.-7. Maple Juice Cove (Cushing): north of a line beginning at the south end of the point at Sheep Point Lane, Cushing, running west to the eastern most point of land on the opposite shore.
- B. Effective immediately, because of non-point source pollution, it shall be unlawful to dig, take or possess any clams, quahogs, oysters or mussels taken from shores, flats, and waters of the following Restricted areas without a special MDMR permit:

1. Unnamed Pt. to Hawthorne Pt. (Cushing): west of a line extending southwest from a red painted post located on the east tip of the un-named point southwest of Bailey Point to the north tip of Hawthorne Pt. Cushing.
2. Wiley Cove (Cushing): west of a line extending southwest from the east tip of Bailey Point to a red painted post located on the east tip of the un-named point southwest of Bailey Point.
3. Otis Cove (St George): south of a line drawn across the most narrow portion of the western cove in Otis Cove, St George.
4. Eastern Otis Cove (St George): south of a line beginning approximately 28 yards from the end of Dickson Lane running west to a red painted post on the opposite shore of an unnamed point.
5. The Narrows (St. George and Cushing): west of a line beginning at the point of land at the northern end of Teel Cove (St. George) running north to the north tip of Hawthorne Point (Cushing); AND east of a line beginning at the Green Can #7 running northeast to a red painted post on the east side of Burton Point; AND north of a line running east from Teel Cove to Green Can #7.
- ~~6. Broad Cove (Cushing): north of a line beginning at a red painted post on the shore north of Bailey Point running northeast to a red painted post on the shore at the end of Lewis Lane.~~
