Shellfish Harvesting Area Classification – Notification of Changes

July 3, 2024 This notice is in effect until repealed or replaced.

Ladies and Gentlemen:

Under the authority of 12 M.R.S.A. § 6172; the Commissioner has made the following changes to Growing Area WY, Islesboro. This notice creates a new Prohibited area in Broad Cove due to point source pollution. An interactive map that allows the user to zoom in to specific areas can be found on the ME DMR website: <u>https://www.maine.gov/dmr/fisheries/shellfish/shellfish-closures-and-aquaculture-leases-map</u>. All existing pollution and biotoxin closures remain in effect.

The boundary descriptions of the area are as follows (struck text is being removed and underlined text is being added):

Prohibited: Effective immediately, because of pollution, it shall be unlawful to dig, take or possess any clams, quahogs, oysters, mussels or whole or roe-on scallops taken from the shores, flats and waters of the following Prohibited areas:

- P1. Sabbathday Harbor (Islesboro): west of a line beginning at the south end of Fire Island, running northeast to the south tip of The Bluffs; AND south of a line beginning at the south tip of The Bluffs running west to the north tip of the unnamed point at the end of Ryder Cove Lane.
- P2. Islesboro Harbor (Islesboro): west of a line beginning at the tip of Hewes Point, then running north to USCG N"2" navigational marker; AND south of a line beginning at USCG N"2" navigational marker running west approximately 950 yards to a prominent unnamed point of land inside Islesboro Harbor, then running west to the opposite shore to a location approximately 125 yards east of the intersection of Main Road and West Bay Road.
- P3. Grindle Point (Islesboro): south and east of a line beginning at the south tip of Grindle Point and running southwest to the USCG N"2" navigational marker; AND north of a line beginning at the USCG N"2" navigational marker, running east to USCG N"6" navigational marker; AND west of a line beginning at the USCG N"6" navigational marker, running north to the granite pier on the mainland, locally referred to as Watt's pier.

- P4. Cradle Cove, Seven Hundred Acre Island (Islesboro): west of a line beginning at the end of a prominent unnamed point on the north side of Cradle Cove, running southeast to the end of the prominent stone pier on the east point of Cradle Cove.
- P5. Southern Islesboro (Islesboro): east of a line beginning at the southwest tip of Sherman Point, running south to the west shore of Thrumcap, then south to the prominent unnamed west point on Pendleton Point, then to the south tip of Pendleton Point; AND west of a line beginning at the south tip of Pendleton Point running northeast to the prominent unnamed east point on Pendleton Point, then running northeast to Gull Point; AND northwest of a line beginning at Gull Point running northeast to the western tip of Resolution Island; AND southwest of a line beginning at the southern tip of Joes Rock, then running west to the unnamed point of land immediately south of the Joes Rock sandbar.
- P6. Broad Cove (Islesboro): North and east of a line beginning at an unnamed point approximately 75 yards southeast of the end of Duffers Lane running southeast to the southwest tip of Broad Point.

Approved: All other shores, flats and waters not described in the above sections are Approved and it is lawful to dig, take or possess any clams, quahogs, oysters, mussels or whole or roe-on scallops (from aquaculture leases with an MOU only) when in the open status.
