#### **Letter of Support**

For the Permit by Rule application thru the DEP, applicants are encouraged to obtain a letter of support from the DMR Shellfish Program Supervisor. Before a letter of support will be issued the Department would ask the applicant to submit a summary of the proposed project.

**Recommendations for applicants:** the following were established out of concern for shellfish related diseases.

- The applicant needs to demonstrate that the shell source is of a locally sourced native shellfish species. (i.e. no shell from out of state or country)
- At this time restaurants will not be supported as suitable sources for shell unless the source and origin of the species can be proven.
- Soft shell clam shell originating from Maine is the preferred material.
- No shellfish shall be used that originate from the Damariscotta or Sheepscot Rivers due to disease issues.
- At this time European oyster shell will not be supported as a suitable source for shell.
- We will only provide letters of support for projects using cured shell to minimize the risk of disease spreading and attracting predators.
- Talk to your Area Biologists for treatment options/applications: research is currently underway.
