PROPOSED RULE NUMBER (*leave blank; to be assigned by Secretary of State*):

BRIEF SUMMARY: This regulation would establish open harvest days and tote limits for the taking of sea urchins by divers, rakers, trappers, and draggers in Zones 1 and 2 for the 2020-2021 season. For Zone 1, seasons are proposed for divers, trappers, rakers and draggers in 2020-2021, from which harvesters may only fish up to 15 days of their choosing, the same number of days allowed during the 2019-2020 season. For Zone 1, the daily tote limit is nine (9), the same as in the 2019-2020 season. For Zone 2, 40-day seasons are proposed for divers, trappers, rakers and draggers in 2020-2021, from which harvesters may only fish up to 30 days of their choosing. This proposal has the same number of fishing days and opportunity days as the 2019-2020 season. For the Whiting & Dennys Bays Limited Access Area in Zone 2, a 15-day season is proposed for Zone 2 divers, trappers, rakers and draggers in 2020-2021. For Zone 2, the daily tote limit is six (6), the same as in the 2019-2020 season.

Chapter 26 - Sea Urchin Regulations

26.07 Sea Urchin Harvesting Season <u>2020-2021</u> 2019-2020 pursuant to 12 M.R.S. §6749. Harvesters may choose 15 of the available days in Zone 1 and 30 of the potential 40 available days in Zone 2.

- 1. Zone 1 [as defined by 12 M.R.S. §6749-N(1)]. Harvesters may choose 15 of the available fishing days.
 - A. Early season for divers, trappers and rakers

The Zone 1 season for divers, trappers and rakers who have certified the early season on forms provided by the Commissioner, is open <u>Mondays, Tuesdays, Wednesdays, Thursdays</u> and Fridays in September and October, 2020. 3, 4, 5, 6, 9, 10, 11, 12, 13, 16, 17, 18, 19, 20, 23, 24, 25, 26, 27, and 30, 2019; and October 1, 2, 3, 4, 7, 8, 9, 10, 11, 14, 15, 16, 17, 18, 21, 22, 23, 24, 25, 28, 29, 30, and 31, 2019. Divers, trappers, and rakers may fish no more than 15 of these days.

B. Late season for divers, trappers and rakers

The Zone 1 season for divers, trappers and rakers who have certified the late season on forms provided by the Commissioner, is open <u>Mondays, Tuesdays, Wednesdays, Thursdays</u> and Fridays in December, 2020; and January and February 2021; except Friday, December 25, 2020 and Friday, January 1, 2021 which shall be closed. December 2, 3, 4, 5, 6, 9, 10, 11, 12, 13, 16, 17, 18, 19, 20, 23, 24, 26, 27, 30, and 31, 2019; January 2, 3, 6, 7, 8, 9, 10, 13, 14, 15, 16, 17, 20, 21, 22, 23, 24, 27, 28, 29, 30, and 31, 2020 and February 3, 4, 5, 6, 7, 10, 11, 12, 13, 14, 17, 18, 19, 20, 21, 24, 25, 26, 27, and 28, 2020. Divers, trappers, and rakers may fish no more than 15 of these days.

C. Season for draggers [in accordance with 12 M.R.S. §6749-V]

The Zone 1 season for draggers is open <u>Mondays, Tuesdays, Wednesdays, Thursdays and</u> <u>Fridays in December, 2020; and January and February 2021; except Friday, December 25,</u> <u>2020 and Friday, January 1, 2021 which shall be closed.</u> December 2, 3, 4, 5, 6, 9, 10, 11, 12, 13, 16, 17, 18, 19, 20, 23, 24, 26, 27, 30, and 31, 2019; January 2, 3, 6, 7, 8, 9, 10, 13, 14, 15, 16, 17, 20, 21, 22, 23, 24, 27, 28, 29, 30, 31, 2020; and February 3, 4, 5, 6, 7, 10, 11, 12, 13, 14, 17, 18, 19, 20, 21, 24, 25, 26, 27, and 28, 2020. Draggers may fish no more than 15 of these days.

- D. Designation of Zone 1 early or late season:
 - (1) A diver, trapper, or raker who holds a sea urchin harvesting license for Zone 1 may not harvest sea urchins in Zone 1 unless that person certifies on forms provided by the Commissioner that the person will fish for or take sea urchins during either the early season or the late season.
 - (2) Divers, trappers and rakers who have certified the early or late season may, between May 1st and August 15th change that certification to the other time period as the time period in which that person will fish for or take sea urchins.

2. Zone 2 [as defined by 12 M.R.S. §6749-N(2)]. Harvesters may choose 30 of the potential 40 days.

A. Early season for divers, trappers and rakers

The Zone 2 season for divers, trappers and rakers who have certified the early season on forms provided by the Commissioner, is open September <u>23</u>, 24, 29 and 30, 2020; and, <u>October 1, 6, 7, 8, 13, 14, 15, 20, 21, 22, 27, 28 and 29, 2020; and November 3, 4, 5, 10, 11, 12, 17, 18, 19, 24, and 25, 2020; and December 1, 2, 3, 8, 9, 10, 15, 16, 17, 21, 22, and <u>23, 2020</u>. <u>24, 25, and 26, 2019; October 1, 2, 8, 9, 15, 16, 17, 22, 23, 24, 29, 30, and 31, 2019; November 5, 6, 7, 12, 13, 14, 19, 20, 21, 26, and 27, 2019; and December 3, 4, 5, 10, 11, 12, 17, 18, 19, 20, 26, 30, and 31, 2019. Divers, trappers, and rakers may fish no more than 30 of these days.</u></u>

B. Late season for divers, trappers and rakers

The Zone 2 season for divers, trappers and rakers who have certified the late season on forms provided by the Commissioner, is open December <u>1, 2, 3, 8, 9, 10, 15, 16, 17, 22, 23, 29, 30, and 31, 2020; and January 5, 6, 7, 12, 13, 14, 19, 20, 26, 27, and 28, 2021; and February 2, 3, 4, 9, 10, 11, 16, 17, 23, 24, and 25, 2021; and March 2, 3, 9, and 10, <u>2021.</u> <u>3, 4, 5, 10, 11, 12, 17, 18, 19, 26, and 27, 2019; January 2, 7, 8, 9, 14, 15, 16, 21, 22, 28, 29, and 30, 2020; February 4, 5, 6, 11, 12, 13, 18, 19, 25, 26, and 27, 2020; and March 3, 4, 5, 10, 11, and 12, 2020. Divers, trappers, and rakers may fish no more than 30 of these days.</u></u>

C. Early season for draggers

The Zone 2 season for draggers who have certified the early season on forms provided by the Commissioner, is open Tuesdays, Wednesdays, and Thursdays in October and <u>November 2020; except Thursday October 1, 8 and 15, 2020, and Thursday, November</u> <u>26, 2020; and December 1, 2, 3, 8, 9, 10, 15, 16, 17, 22, and 23, 2020; and January 5, 6,</u> <u>7, 12, 13, 14, 19 and 20, 2021.</u> 2019, and Tuesdays, Wednesdays, and Thursdays in <u>November 2019, except Thursday, November 28 shall be closed; and Wednesdays and Thursdays in December, and December 27 2019, except Wednesday December 25 shall be closed; and January 2, 3, 8, 9, 15, and 16, 2020.</u> Draggers may fish no more than 30 of these days.

D. Late season for draggers

The Zone 2 season for draggers who have certified the late season on forms provided by the Commissioner, is open December <u>1, 2, 3, 8, 9, 10, 15, 16, 17, 21, 22, 23, 28, 29, and 30, 2020; and January 5, 6, 7, 12, 13, 14, 19, 20, 26, 27, and 28, 2021; and February 2, 3, 4, 9, 10,11, 16, 17, 23, and 24, 2021; and March 2, 3, 9, and 10, 2021. 3, 4, 5, 10, 11, 12, 17, 18, 19, 26, and 27, 2019; January 2, 7, 8, 9, 14, 15, 16, 21, 22, 28, 29, and 30, 2020; February 4, 5, 6, 11, 12, 13, 18, 19, 25, 26, and 27, 2020; and March 3, 4, 5, 10, 11, 11, and 12, 2020. Draggers may fish no more than 30 of these days.</u>

- E. Designation of Zone 2 early or late season:
 - (1) A person who holds a sea urchin harvesting license for Zone 2 may not harvest sea urchins in Zone 2 unless that person certifies on forms provided by the Commissioner that the person will fish for or take sea urchins during either the early season or the late season.

(2) A person who has certified the early or late season may, between May 1st and August 15th change that certification to the other time period as the time period in which that person will fish for or take sea urchins.

26.19 Limited Access Areas:

Transiting exception:

Any vessel possessing urchins onboard, may transit the Limited Access Area, only if the vessel has all fishing gear (dredges, drags, regulators, buoyancy compensators, fins, tanks, weight belts) securely stowed. Securely stowed shall mean the main wire shall not be shackled or connected to the dredges or drags, and the towing swivel will be at the block or on the winch for draggers, while regulators, buoyancy compensators and tanks should be disconnected with fins and weight belts removed for divers.

(1) Whiting and Denny's Bay Area (Zone 2). Harvesters may choose up to 15 days of the following applicable season open days for the Whiting and Denny's Bay limited access area to fish within their 30 days available for harvest.

A. Early season for divers, trappers and rakers

It shall be unlawful to fish for, take, or possess urchins west of a line starting at the western end of Mahar Point, Pembroke, due south to the nearest point of land on Crow Neck, Trescott, to include all of Whiting and Denny's Bay except by divers, trappers, and rakers who have certified the early season on forms provided by the Commissioner, on September <u>29, and 30, 2020; and October 8, 13, 15, 20, 22, and 29, 2020; and November 5, 12, 19, and 25, 2020; and December 3, 10, and 17, 2020.</u> 25 and 26, October 15, 17, 22, 24, and 31, November 7, 14, 21, and 27 and Thursdays in December 2019...

B. Late season for divers, trappers and rakers

It shall be unlawful to fish for, take, or possess urchins west of a line starting at the western end of Mahar Point, Pembroke, due south to the nearest point of land on Crow Neck, Trescott, to include all of Whiting and Denny's Bay except by divers, trappers and rakers who have certified the late season on forms provided by the Commissioner on December 3, 10, 17, and 31, 2020; and January 7, 12, 14, 19, and 28, 2021; and February 4, 11, 16, and 25, 2021; and March 2 and 9, 2021. Thursdays in December 2018, and Thursdays in January, February, and March, 2019, except March 21 and 28, 2019, which shall be closed.

C. Early season for draggers

It shall be unlawful to fish for, take, or possess urchins west of a line starting at the western end of Mahar Point, Pembroke, due south to the nearest point of land on Crow Neck, Trescott, to include all of Whiting and Denny's Bay except by draggers who have certified the early season on forms provided by the Commissioner, on Wednesdays in October, November and December <u>2020</u> 2019, except December <u>30</u> 25, which shall be closed; and January <u>6, 13 and 20, 2021</u>. 3, 8, and 15, 2020.

D. Late season for draggers

It shall be unlawful to fish for, take, or possess urchins west of a line starting at the western end of Mahar Point, Pembroke, due south to the nearest point of land on Crow Neck, Trescott, to include all of Whiting and Denny's Bay except by draggers who have certified the late season on forms provided by the Commissioner, on Wednesdays in December, <u>2020</u> 2019, except December 25, which shall be closed; and Wednesdays in January, <u>and except January 1, 2020</u>, which shall be closed; February <u>2021</u> 2020; and March <u>3</u>, and 10, 2021. 3, 4, 10, and 11, 2020.

(2) Blue Hill Bay Area (Zone 2). Harvesters may fish in the Blue Hill Bay limited access area only in accordance with the following provision:

It shall be unlawful to fish for, take, or possess urchins in Blue Hill Bay, north of a line starting at southernmost tip of Lopaus Point to the northern most point of Black Island; continuing from the westernmost tip of Black Island to the northern most tip of Swans Island Head; continuing to the most southeastern point of Naskeag Point, Brooklin except by draggers, divers, trappers, and rakers who possess aboard their fishing boat, a Global Positioning System (GPS) tracking unit provided by the Department. The spatial tracker must be turned on and continuously recording data for the entire duration of each season, chosen by the harvester. This limited access area will sunset April 1, 2022.

26.20 Targeted Closures

It shall be unlawful to fish for, take, or possess urchins taken by any method within any of the following closed areas. All directions are relative to True North (not magnetic).

Transiting exception:

Any vessel possessing urchins onboard, may transit these targeted closures, only if the vessel has all fishing gear (dredges, drags, regulators, buoyancy compensators, fins, tanks, weight belts) securely stowed. Securely stowed shall mean the main wire shall not be shackled or connected to the dredges or drags, and the towing swivel will be at the block or on the winch for draggers, while regulators, buoyancy compensators and tanks should be disconnected with fins and weight belts removed for divers.

1. Cat Ledges Area:

It shall be unlawful to fish for, take, or possess urchins inside a line drawn from the southwestern tip of Pratt Island, Southport Island, then south to Red Gong "4CL", then northeast to the prominent point on the eastern shore of Christmas Cove.

26.50 Urchin Electronic Reporting

For the purpose of this section, "DMR-issued reporting device" means a transaction card or other Department developed and approved technology provided for the purpose of recording urchin transactions.

- Eligibility. In order to be eligible for a DMR-issued device for the electronic reporting of urchin landings, an individual must be licensed according to 12 M.R.S. §6748, 6748-A, 6748-D, or 6302-A subsection 3 paragraph B. Valid reporting devices may only be issued by the Department of Marine Resources.
- Harvester Use. It is unlawful for an individual licensed under 12 M.R.S. §6748, 6748-A, 6748-D, or 6302-A subsection 3 paragraph B to sell or transfer urchins the license holder has taken, unless the harvester presents a DMR-issued reporting device and records each transaction. DMR-issued reporting devices may only be used to sell urchins which were harvested by the

individual identified on the reporting device. A law enforcement officer may seize or deactivate the reporting device of an individual who has used their reporting device to sell urchins they did not harvest. The act of utilizing your reporting on any given day will be considered as one fishing day, between the hours of 12:00 am-11:59pm.

- 3. Dealer Use. It is unlawful for a person licensed under 12 M.R.S. §6851 subsection 2-B, subsection 2-C, or §6852 to purchase or transfer urchins from an individual licensed under 12 M.R.S. §6748, 6748-A, 6748-D, or 6302-A subsection 3 paragraph B, without recording the transaction using the electronic recording device specified by the Department for that purpose. DMR provided reporting software must be synchronized for updates to the reporting system prior to the purchase of urchins on each fishing day. A person licensed under 12 M.R.S. §6851 subsection 2-B or subsection 2-C may not purchase urchins from a harvester that does not present a DMR-issued reporting device. In the event of any failure of the reporting software or equipment, the Commissioner may authorize the use of paper reports until such time as the system is operational.
- 4. Records required. A person licensed in accordance with 12 M.R.S. §6851 subsection 2-B or subsection 2-C shall maintain documentation to account for all urchins in their possession. Any urchins legally obtained from other jurisdictions must have sufficient documentation to demonstrate their origin. Failure to provide proper documentation will be prima facie evidence that the urchins are illegal and are subject to seizure.
- 5. The Department will deactivate the reporting device of any individual who has met or exceeded their sea urchin harvest days. The onus is on the license holder to track days fished; harvesting beyond the number of allocated season days is considered fishing out of season and is prohibited.

PRINCIPAL REASON(S) OR PURPOSE FOR PROPOSING THIS RULE: [see §8057-A(1)(A)&(C)]

This regulation would establish open harvest days and tote limits for the taking of sea urchins by divers, rakers, trappers, and draggers in Zones 1 and 2 for the 2020-2021 season. For Zone 1, seasons are proposed for divers, trappers, rakers and draggers in 2020-2021, from which harvesters may only fish up to 15 days of their choosing, the same number of days allowed during the 2019-2020 season. For Zone 1, the daily tote limit is nine (9), the same as in the 2019-2020 season. For Zone 2, 40-day seasons are proposed for divers, trappers, rakers and draggers in 2020-2021, from which harvesters may only fish up to 30 days of their choosing. This proposal has the same number of fishing days and opportunity days as the 2019-2020 season. For the Whiting & Dennys Bays Limited Access Area in Zone 2, a 15-day season is proposed for Zone 2 divers, trappers, rakers and draggers in 2020-2021. For Zone 2, the daily tote limit is six (6), the same as in the 2019-2020 season.
