Explanation of report form (All code lists will be provided with form instructions)

Harvester Name: Your name as it appears on your scallop license.
State Landings #: Your DMR landings number.
Phone: This is where you can be reached in case the form has not been filled out correctly.
Send More Logbooks: Only checked if you are about to run out of forms.
Vessel Name: Name of your boat.
Hull ID: Enter either your Maine vessel registration number (hull ID) or Coast Guard Documentation number.
Year and Month: Enter the year and month for which you are reporting your fishing activity.
Date: Fishing day (date).
Of Crew: Number of people including the captain.
Gear Type: "DRCS" indicates *chain sweep dredge*; "DRR" indicates *rock dredge*; "DIV" indicates *dive gear*.
Gear Quantity: Number of gears used. Divers skip this field.
Of Sets: Number of tows or dives.
Set Time: The average fishing time per tow or bottom time per dive. Be sure to check the box for either hours (h) or minutes (m).
Total Gear In Water: Scallop harvesters will skip this field.
Total Buoys Fished: Scallop harvesters will skip this field.
Depth: The average depth you were fishing at in either fathoms (FA) or feet (FT). Be sure to check the box for either fathoms (FA) or feet (FT).
Area Fished: Latitude and longitude.
Sea Time: Estimate of the total fishing time that day, from dock to dock.
Species: Indicate the species landed that trip. "SCAL" indicates *sea scallops*.
Pounds: The estimated meat pounds landed that trip.
Dealer Lic # Or Use Code: Indicate the dealer you sold to by recording the dealer's license number (you can obtain that number from your dealer or from DMR) or if you did not sell to a dealer, provide a use code (e.g. "FO" indicates you retailed to the public for food).
Port Landed: Indicate the port where you landed the catch.
Signature: Your signature.
